## 2 GLOSSARY OF TERMS

Terms written with capital letters or marked with *bold*, *italic* in the appendices are explained in the table below.

<b>Access control</b>	<b>Access control</b> is a means of ensuring that the resources of a data processing system can be accessed only by authorised entities in authorised ways. More specifically, the purpose of access control to <b>Helseplattformen</b> is to ensure that health personnel have access to the data and functionality that are needed to perform their work tasks, while at the same time preventing access to non-authorised users.	
<b>Administrative procedures</b>	<b>Administrative procedures</b> assess a patient's need for care and assistance based on physical and mental functionality level. The assessment is directly linked to a patient and results in a decision which reflects his/her right for assistance and support from the municipal health- and welfare services. Administrative procedures are conducted at various services by virtue of different legislation.	
<b>Administrator</b>	A supervisor who might have a special user access for system administration. An administrator is employed in the user organisation.	
<b>Adverse event</b>	An <b>adverse event</b> is an incident in relation to health treatment and care that causes or has the potential to cause harm to a patient. Causing harm is not limited to bodily harm, but also includes harm in terms of e.g., breach of privacy.

Individual plans require consent of the patient or patient representatives on their behalf. The same applies to the appointment of the coordinator. The coordinator shall ensure the necessary follow-up of the individual patient.
