1 GENERAL

This Appendix lists the Customers under the Contract. The Customers comprise the Central Norway Regional Health Authority ("HMN") and its Health Trusts, the City of Trondheim, as well as the other municipalities in the Central Norway Health Region¹ (84 municipalities). The EHR solution is for the municipalities purchased in the form of options. Additionally General Practitioners (GPs) in the region and any other actor, both public entities, and other non-profit and/or privately owned providers of health services in the Central Norway Health Region, shall be regarded as Customers, and have options to take part in the EHR solution if designated by Helseplattformen. A further description of the Customers is provided in this Appendix.

The Customers are organised and financed in various ways, but have in common that they are a part of the Central Norway Health Region. The list of Customers thus expresses the broad cooperation that comprises Helseplattformen, to the benefit of the patient. The list of Customers reflects the current organisational structure. It must be expected that there will be changes to this structure during the Term.

The rights and obligations under the Contract are executed by Helseplattformen on behalf of the Customers. A common entity will act/be responsible on behalf of the Customers towards the Contractor.

During the Term of this Agreement the organisational structure and ownership of the Customers or the entity executing rights and obligations on behalf of the Customers may be changed due to reorganisation or from organic growth, from mergers, acquisitions or divestitures. Irrespectively, the new entities will be governed by the Contract regardless of whether the reorganisation concerns HMN or the municipalities or otherwise.

Note that in general, all deliveries and pre-requisites or assumptions relevant for the implementation of the EHR solution, both related to the Contractor's Deliverables and the Customer Furnished Assets (CFA), cf. *Appendix C7*, shall be taken into account in the Contractor's Project and Progress Plan, cf. *T Appendix 3*.

2 THE CENTRAL NORWAY HEALTH REGION HEALTH TRUSTS

The specialist health services in the Central Norway Health Region, comprising of the Central Norway Regional Health Authority (HMN) and their Health Trusts/subsidiaries as set out in Table 1, shall be regarded as Customers under the Contract. Enterprises established by, or contracted by HMN and/or the Health Trusts to deliver health services in the Central Norway Health Region shall also be regarded as Customers.
